Dear Council.

Aniin, Hello.

I am an indigenous anishinaabe woman. I thank you for taking the time to read my comments from our treaty 6 territory.

I am a CIS woman. I was assigned and identify as she/her/woman \*Ihkwē\*.

I was sexually abused as a child.

I was sexually assaulted as an adult.

The perpetrators of these crimes were CIS straight men. assigned male at birth and identified as such.

The people whom I've found safety with over the years are the queer community.

This attack on trans folks, specifically trans women comes from nothing other than hate and prejudice. Trans women statically have not caused harm to our community. Statically speaking my sons who identify as boys are at greater risk sharing washrooms and change rooms with cis straight men than I or our daughter's are sharing space with all women (\*trans\* women).

The unfounded accusations, blatant lies need to be stopped and Saskatoon needs to continue to support, care for and provide safety to transfolks who are at a much higher safety risk than other demographics.

I support the LGBTQ2S community and will not sit quietly while a bunch of bigots cause harm on our treaty land.
