Comments:

I want to express my support for the Shaw Centre's policy allowing people to choose the changing room that aligns with their gender identity. The current Shaw Centre change room policy aligns with The Canadian Charter of Rights and Freedoms. Specifically, the 2017 amendment to include gender identity and expression in Section 15, the Equality Rights section of the Canadian Charter of Rights and Freedoms.

Some speakers today (March 8th) want to protest the Shaw Center's inclusive policy; this protest is transphobic and contradicts The Canadian Charter of Rights and Freedoms. I have seen news coverage by The StarPhoenix and The Western Standard News claiming that the transphobic protest of the Shaw Centre is in response to an anonymous post on Facebook. The anonymous post in a Facebook mother's group claims that a trans woman, described in transphobic terms by both media outlets as a "man that identifies as a woman," used a woman's change room, which distressed the anonymous mother. The complainant has not been identified, and the inciting incident is merely alleged.

I learned that Ward 3 Councillor Kirkton received threatening phone calls and emails in response to the alleged Shaw Centre incident. These transphobic individuals directed their anger at Counsellor Kirkton because the Shaw Centre is in Ward 3. I am saddened to hear that transphobic people have threatened a city council member. These same people have harassed gender-diverse people, including me. Gender-diverse people and allies have been counter-protesting the transphobic protests at the Shaw Centre. We will continue to support Saskatoon's implementation of policy that aligns with the Canadian Charter of Rights and Freedoms.

I call on The Members of Saskatoon City Council, His Worship Mayor Charlie Clark, Ward 3 Counsellor Mr. Kirkton, and the Shaw Centre to condemn the transphobic protests that contradict the Canadian Charter of Rights and Freedoms, and have threatened a member of Saskatoon City Council.
