**Comments:**

I wish to address council to express my concern for residents living on the 500 block of 8th St. East (between Eastlake and Broadway Avenues) with respect to having sufficient parking if Bylaw No. 9884 is passed by council and permit to construct is issued to Saska Land Development, as per amendments; City of Saskatoon Community Bylaw No. 9700 (OCP) and Zoning Bylaw No. 8770. Approval of this proposed zone change and building will necessitate, without fee, issue of residential parking permits to the organization/ agency I am representing.

This proposed ninety dwelling units and commercial development will only exasperate our current overcrowded parking predicament without any passing amendments of a 24 hour, daily 2-hour limit for non-residents, and, if passed, a dreaded inconvenience for worshippers of the 2 churches proximal to the intersection of 8th St. East and Broadway Ave.
