BYLAW NO. 9886

The Traffic Amendment Bylaw, 2023 (No. 2)

The Council of the City of Saskatoon enacts:

Short Title

1. This Bylaw may be cited as *The Traffic Amendment Bylaw, 2023 (No. 2)*.

Purpose

- 2. The purpose of this Bylaw is to amend *The Traffic Bylaw* to:
 - (a) update the definition of Fringe Festival;
 - (b) update the Fringe Festival parking area map;
 - (c) add a provision stating that two parking permits shall be provided to each dwelling unit or other type of unit located in the Exhibition Week and Fringe Festival parking areas; and
 - (d) prohibit the misuse of Exhibition Week and Fringe Festival parking permits.

3. The Traffic Bylaw is amended in the manner set forth in this Bylaw.

Section 2 Amended

4. Clause 2(1)(s) is amended by adding "or around" after "on".

Section 56 Amended

- 5. Subsection 56(4) is repealed and the following substituted:
 - "(4) Two Exhibition Week or Fringe Festival parking permits shall be issued annually to each dwelling unit or other type of unit located in the Exhibition Week or Fringe Festival parking areas, as identified in Schedule No. 13 and Schedule No. 14, respectively.
 - (4.1) Parking permits issued pursuant to subsection (4) are valid only in the areas shown in Schedule No. 13 or Schedule No. 14 and only during Exhibition Week or Fringe Festival, respectively.".

New Section 56.4

6. The following section is added after section 56.3:

"Misuse of Parking Permit

- 56.4 (1) In this section, "parking permit" means a parking permit issued pursuant to subsection 56(4).
 - (2) No person shall:
 - (a) sell or gift a parking permit;
 - (b) create, use, display, sell or gift a counterfeit parking permit;
 - (c) fail to report a lost or stolen parking permit; or
 - (d) fail to comply with the conditions or directions endorsed on a parking permit.
 - (3) In addition to fines or prosecution, contravention of subsection (2) may result in the following:
 - (a) cancellation of an existing parking permit;
 - (b) restrictions on the issuance of future parking permits.".


