The Standing Policy Committee on Planning, Development and Community Services, at its meeting held on April 5, 2023, considered the above-noted matter and resolved:

1. That the report be forwarded to the Diversity Equity Inclusion Advisory Committee for their feedback;
2. That the Standing Policy Committee on Planning, Development and Community Services recommend to City Council that the report be forwarded to the Board of Police Commissioners affirming its opposition to any sort of street harassment, offering support to the SPS for the future work of the Hate Crimes Unit, and requesting reporting to City Council on Hate Incident reports and trends in Saskatoon, and how Saskatoon Police Service is considering the gap between hate incidents and hate crimes; and
3. That the Administration report back to the appropriate Standing Policy Committee regarding targeted efforts underway by the City to combat discrimination, either by incorporating this information into planned reporting cycles, or through a new report.
