I am writing with my bleeding heart for Natasha Fox death and know Councillor Block (Ward 6) has introduced motions to council that would attempt to address cycling safety concerns at the intersection of College Dr. and Wiggins Ave. These motions include:

- a third party road safety audit at the intersection
- funding for the above audit
- an update on the implementation of the Active Transportation Plan
- a budget option for an annual Road Safety Audit program

I support these and any future motions that urgently address safety for people riding bikes with a focus on infrastructure for all ages and abilities.

I know we attract so many people around the world to our beautiful city but they will not stay because it is not safe to travel on their bikes. I envy cities like Calgary and Vancouver and miss my friends who moved away from Saskatoon for the reason bike friendly cities offer: Safe commute on your bike due to separated bike lanes year around. I know you will say we are winter city and nobody bikes in winter. I do and I know many people doing it. I have been biking since I moved here in 2007. I bike using MW trail and without that trial my commute would be miserible and dangerous, even I obey all the rules of the road.
