Attention, His Worship Mayor Charlie Clark, City Councillors, and others in attendance.

Riide has operated in Saskatoon for over 50 years and is the leader in the Taxi industry in our great city. The first to introduce upscale service, the first to bring in wheelchair and ambulatory services and most recently, the first to bring in fully electric vehicles.

We are fortunate to operate with many passionate plate owners who remain invested in this industry. And equally as important, are the operators who continue to reinvest their hard-earned money back into our community.

As a company, riide continues to invest in this industry through first to market initiatives, on-going driver training, technological advancements, and our work in the community through our marketing and countless donations and sponsorships.

In 2011, city administration developed a Taxi Cost Index (TCI). The operational expenses that the TCI measures include fuel, maintenance, insurance, license fees, and earnings.

The TCI is typically calculated annually using data from Statistics Canada and is provided to the industry to help guide discussions on any necessary fare increases to ensure they remain in line with operating cost.

As of February 2023, the operating cost relative to the January 2011 baseline has increased by **32.4%**. Taxi fares have historically increased every 4 years since 2011 and in keeping up with this practice, the next increase would be in Q3 of 2024. Comparing the TCI calculations to the last fare adjustment in October of 2020, would indicate a **16.1%** increase is required.

There is a proposed drop rate increase from \$3.75 to \$4.75 that could potentially be adopted for this fall. This amount covers a 7% portion of the 16.1% increase that we desperately need to catch up on, but it's a start. With that said, we are asking that consideration is given to fast track this increase so that our industry, who has sustained so much inflation in the last three years, can provide a small amount of financial relief to those that have invested in this industry and will continue to do so.

I can assure you that in October of 2020, I certainly didn't see paying \$6 for a cantaloupe, or \$163.9 for a litre of fuel. Local businesses should be a priority, and this is an opportunity to show your commitment to the taxi industry.



Unfortunately, there are certain rideshare companies who can adjust their fees without impunity and we feel this is a fair and equitable adjustment. Thank you for your consideration and we anticipate a quick resolution on this matter.
