Following discussion, the Commission was further informed of the following:

- Besides the Hotel and Spa and existing Clubhouse, there is no retail development included in the application
- Speed limit reductions are recommended for Lorne Avenue and access to the Willows, and would be in place at time of development
- Traffic calming measures will be considered along Cartwright, keeping short-cutting, speeding, and emergency vehicle call-time in mind
- Every neighbourhood throughout the city has a mix of fee-simple and condominium units, and both fee-simple units and condos pay property taxes which pay for base services
- The Willows has lower density than typical neighbourhood design
