

Various Bylaw Amendments to Update References from the Queen to the King

ISSUE

This report submits the following bylaws for City Council's consideration:

- Bylaw No. 9909, *The City of Saskatoon Fire and Protective Services Department Superannuation Plan Amendment Bylaw, 2023*;
 - Bylaw No. 9910, *The Dangerous Animals Amendment Bylaw, 2023 (No. 2)*;
 - Bylaw No. 9911, *The Municipal Wards Commission Amendment Bylaw, 2023*; and
 - Bylaw No. 9912, *The Saskatoon Licence Appeal Board Amendment Bylaw, 2023*
- (collectively, the "Bylaws").

The Bylaws update references from the Queen to the King.

BACKGROUND

At its [February 22, 2023 Regular Business Meeting](#), City Council considered a report of the City Solicitor's Office dated February 22, 2023, and resolved:

1. That City Council approve the proposed amendments to:

- Bylaw No. 8225, *The City of Saskatoon Fire and Protective Services Department Superannuation Plan Bylaw, 2003*;
- Bylaw No. 9537, *The Code of Ethical Conduct, 2019*;
- Bylaw No. 8176, *The Dangerous Animals Bylaw, 2003*;
- Bylaw No. 8164, *The Municipal Wards Commission Bylaw, 2002*;
- Bylaw No. 9036, *The Saskatoon Licence Appeal Board Bylaw, 2012*; and

2. That the City Solicitor be requested to prepare the necessary amendments to update references from the Queen to the King.

DISCUSSION/ANALYSIS

In accordance with City Council's instructions, we are pleased to submit the Bylaws for City Council's consideration.

Amendments to *The Code of Ethical Conduct, 2019* were made clerically as references to the Queen in that Bylaw appeared in information notes only.

The Dangerous Animals Bylaw, 2003 has additionally been amended to repeal gender specific language.

The International Association of Fire Fighters, Local No. 80 was notified of and consented to this housekeeping change being made to *The City of Saskatoon Fire and Protective Services Department Superannuation Plan Bylaw, 2003*.
