

BYLAW NO. 9914

The Waste Amendment Bylaw, 2023 (No. 2)

The Council of the City of Saskatoon enacts:

Short Title

1. This Bylaw may be cited as *The Waste Amendment Bylaw, 2023 (No. 2)*.

Purpose

2. The purpose of this Bylaw is to amend *The Waste Bylaw, 2022* to:
 - (a) clarify the fees for recyclable and organic material collection services;
 - (b) amend the fees for disposing of waste at the Waste Management Centre; and
 - (c) make minor housekeeping amendments.

Bylaw No. 9844 Amended

3. *The Waste Bylaw, 2022* is amended in the manner set forth in this Bylaw.

Section 2 Amended

4. Section 2 is amended by adding the following clauses after clause (j):
 - “(j.1) **“dwelling unit”** means a dwelling unit as defined in the *Zoning Bylaw*;
 - (j.2) **“elm tree”** means an elm tree as defined in *The Dutch Elm Disease Regulations, 2005*;”.

Section 24 Amended

5. Section 24 is repealed and the following substituted:

“Mandatory Collection Fees for Recyclable and Organic Materials

24. (1) The collection fees set out in Schedule “D” shall be added to the utility bills of each dwelling unit that is provided recyclable or organic material collection services.
- (2) For the purposes of subsection (1):
- (a) a dwelling unit is considered to be provided collection services if the City makes these services available to the dwelling unit;
 - (b) the fees shall be charged regardless of whether a person chooses to utilize the collection services or chooses to return to the City or otherwise not accept the approved containers made available; and
 - (c) a residence with more than one dwelling unit must, unless otherwise permitted by the City, pay collection fees in respect to each dwelling unit at the residence.”.

Schedule “C” Amended

6. Clause 1(d) of Schedule “C” is amended by striking out “as defined by *The Dutch Elm Disease Regulations, 2005*”.

Schedule “D” Amended

7. Schedule “D” is repealed and the schedule marked as Schedule “A” to this Bylaw is substituted.

Coming Into Force

Container Type	Fee
Recyclable Material Roll-Out Cart	\$0.245562 per day per dwelling unit (approximate average monthly cost per dwelling unit: \$7.47)
Recycling Bin - Multiple Unit Residence	\$0.126890 per day per dwelling unit (approximate average monthly cost per dwelling unit: \$3.86)
Organic Material Roll-Out Cart	\$0.221236 per day per dwelling unit (approximate average monthly cost per dwelling unit: \$6.73)

Schedule “F”

Waste Management Centre Fees

Definitions

1. In this Schedule:

- (a) **“clean soil”** means soil that has been pre-approved by the City to be disposed of at the Waste Management Centre and that, in the opinion of the City:
 - (i) does not contain any foreign debris such as wood, stumps, branches, concrete, plastic or large rocks; and
 - (ii) has chemical concentrations of regulated substances below levels acceptable to the City;
- (b) **“electronics”** means any electronics accepted by the City for disposal at the Waste Management Centre;
- (c) **“metals”** means any metals accepted by the City for disposal at the Waste Management Centre, which may include appliances, automotive batteries and propane cylinders.

Entrance Fees

2. An entrance fee of \$15.00 shall be paid by each vehicle each time it enters the Waste Management Centre to dispose of anything other than the following:

- (a) concrete or brick;
- (b) metals;
- (c) electronics;
- (d) household batteries;
- (e) tires without rims, up to a maximum of 10 per entry;
- (f) deliveries comprised entirely of clean soil;
- (g) bicycles;

- (h) automobile oil;
- (i) recyclable material.

Weight Fees

- 3. (1) The following pro rata weight fees shall be paid for deliveries of the following types of waste that weigh 150 kilograms or more:
 - (a) \$0.00 per tonne for deliveries of any of the waste listed in clauses 2(b) to (i);
 - (b) \$50.00 per tonne for deliveries of concrete or brick;
 - (c) \$130 per tonne for deliveries of special waste, other than elm trees;
 - (d) \$105.00 per tonne for deliveries of any waste to which clauses (a) to (c) do not apply.
- (2) The minimum pro rata weight fee for a delivery of special waste, other than elm trees, shall be \$275.00.

Special Disposal Fees

- 4. The following additional special disposal fees apply:
 - (a) \$10.00 per pig, sheep, cat, dog or other small animal carcass;
 - (b) \$20.00 per horse, cow or other large animal carcass;
 - (c) \$20.00 per refrigerator, freezer, air conditioner or other appliance that contains refrigerants;
 - (d) any other rate as may be set by the General Manager for waste that, in the opinion of the General Manager, requires special handling.
