**NEIGHBOURHOOD CONCEPT PLAN NOTICE**

**ROSEWOOD NEIGHBOURHOOD CONCEPT PLAN – PROPOSED AMENDMENT**

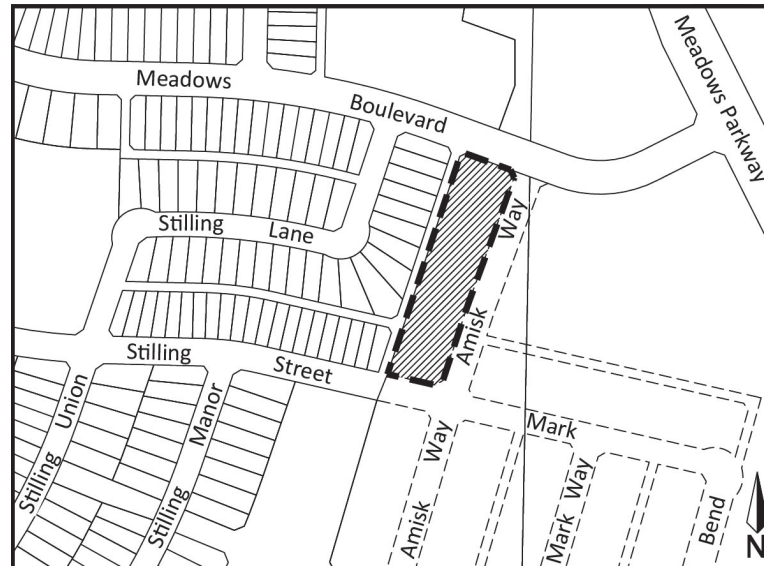
Saskatoon City Council will consider an amendment to the Rosewood Neighbourhood Concept Plan proposed by Arbutus Properties. The proposed amendment would redesignate the subject site from Single Family to Multi Family and relocate the existing predesignated Residential Care Home sites from the intersection of Meadows Boulevard and Amisk Way to a block in the southern portion of the neighbourhood, at the intersection of Rosewood Drive and Kostiuik Crescent.

**REASON FOR THE AMENDMENT** – The area is currently undeveloped and the proposed Rosewood Neighbourhood Concept Plan amendment, in conjunction with a Zoning Bylaw amendment (Bylaw No. 9907), would accommodate the proposed development of street townhouses on the subject site. To accommodate the proposed development, the predesignated Residential Care Home sites are proposed to be provided for in the southern portion of the neighbourhood.
