

As a researcher who studies the social determinants of health I firmly support the New Central Library and support borrowing 87.5 M to make this a reality. Libraries are critical social infrastructure in cities like ours and our central library no longer meets the needs of our community. I recently read Palaces for the People that examines how social infrastructure can literally mean the difference between life and death for some, and quality of life for others. Our city very much needs a new Central Library that meets the information needs of our community now and into the future.

I like to visit libraries in other cities when I travel and I have seen what incredible places they can be. Places like Halifax and Calgary have built beautiful new libraries in the last couple of years that include maker spaces where you can access state of the art technology for free. I have seen recording studios, rental space for artists, 3D printing and book binding. The new Calgary library has a teens only space with the needs of young people in mind. It's also exciting to see these new libraries embracing their role in providing support for homeless and underhoused people, as well as social workers and counselling for people going through difficult experiences.

We need more space for newcomers in our city to use free services to become more connected to others in our community. We need a library that is much more physically accessible for those who face mobility challenges.

We live in a world where there are fewer and fewer safe, comfortable spaces that people can access without needing to spend money. With so few free public spaces anymore and with rising inequality the need is only going to get more critical.

Climate change is going to mean that critical infrastructure like libraries is only going to get more expensive to build and given we are already well past due for a new library I feel that this is THE moment to build.

Our downtown library especially is more than books to so many people. It's a resource for legal advice, resume-building, newcomer outreach... and did you know there are social workers to connect people who are struggling with the right community service, or just to be a safe person to talk with? And everything, from computer access, skill-building services, and homework help to art workshops and guest speakers, everything EVERYTHING is free and accessable to all. Something I learned while volunteering with READ Saskatoon is that poverty is fought with literacy and community. The Library is the heart of of that.

Our downtown library, the main branch, is not up to code, and was built for a population half our size. It's time for a new build and yes, the proposal means an 87.9 million dollar investment by the City, but what a centre it would be. 
