Dear Mayor Clark and City Council,

I have in the past written to express my full support for the Low Emissions Community Plan (LECP), and today I am writing to urge Council to fund the plan adequately so that implementation may begin in earnest. I was relieved to see leadership from Council in supporting continued work on the LECP at its August 26th meeting, yet this was only a first step. It is critical to note and remember that the LECP is a comprehensive emissions-reductions strategy in which the various initiatives work together to meet our commitments; it is not a list of suggested plans, some of which can be adopted and some ignored. The Plan acknowledges that we will already miss our initial 2023 targets by that date - however, with full implementation, we can be on track to meet our 2050 targets, which is critical for addressing the climate crisis here in our city. Fortunately, the plan also has many co-benefits, and full implementation will help us invest in a city not only more sustainable, but more accessible and inclusive as well.

I understand that the City has limited resources, and there are many priorities from outside the LECP that merit funding, such as the implementation of the Triple Bottom Line approach and curbside organic bin purchases. This is one reason why it is crucial that the City develop long-term, sustainable funding strategies for the LECP, so that it is not competing with other urgent priorities and so that its various initiatives need not be debated at budget deliberations year after year. Administration has proposed a suite of potential options, and a combination of them such as the development of a dedicated Green Fund (funded by savings from implementation of the LECP), carbon tax rebates, and savings from general emissions reductions could go a very long way to creating stable funding to ensure full implementation of the LECP and the long-term savings it represents.

This is a critical time for Council to demonstrate leadership on this file, and Saskatoon residents stand to gain a lot through the full implementation of this plan. Please remember that it is designed as a comprehensive strategy and requires stable, long-term funding.

1. That the priorities list for funding Low Emissions Community Plan (LECP) includes all action items that were recommended in the Low Emissions Community Plan report. I understand that some items were excluded from consideration. Since this is a comprehensive plan, it is inconsistent to exclude some items, and thereby, render them inaccessible to council for funding consideration.
2. That Council establish a mechanism that is specifically established to ensure long-term funding to implement action items identified in the LEC Plan. To secure ongoing commitment to- and effective implementation of the plan, I believe Council needs to ensure that this initiative receives a commitment to ongoing funding support, so that implementation does not rely on ambiguous funding that would result if LECP funding was left to annual consideration at Council's budget deliberations.

We are writing to follow up on our letter from August of this year, in which we expressed our support for the Low Emissions Community Plan (LECP) and our willingness to engage with the City and the broader community around issues of education and implementation. We were pleased to see Council decide to move forward with continued work on the plan. We feel that the upcoming budget deliberations provide another important opportunity for us to share our concerns as a community-based organization dedicated to the vision of a sustainable and just transition to a low-carbon community. These deliberations are a critical juncture in moving towards the implementation of this exciting plan and opportunity.

As we noted in August, we support bold climate action based on the best science available and thus in line with IPCC and international targets; while the City's current targets are not in line with the IPCC's aspirational goal of limiting warming to 1.5 C, we appreciate the City's willingness to set ambitious and achievable targets, and expect that the City will continually review said targets and bring them into alignment with international goals. Dear Mayor Clark and Members of City Council,

The Saskatchewan Environmental Society has been a strong supporter of the Low Emissions Community (LEC) Plan since its release this summer. The full implementation of the 40 action measures in this Plan would represent a serious attempt by the City to achieve the emissions reduction goals City Council set in 2017 - particularly the goal of an 80% reduction in community-wide emissions by 2050. Additionally, all but nine of the action measures in the Plan result in savings, and the anticipated overall net return by 2050 exceeds \$14 billion.

The primary obstacle in moving forward with the LEC Plan to realize significant greenhouse gas reductions and cost savings, is identifying and applying adequate funding. We understand from information provided for the August 26 City Council meeting that the LEC Plan funding required is approximately \$5.5 million in 2020 and \$4.2 million in 2021. We note from the upcoming budget deliberations that there is currently \$19 million in available funding (from the RCE, MMSW and Federal Gas Tax) to advance City Council priority projects in 2020 and 2021, and therefore more than enough to fund 2020-2021 LEC initiatives. We strongly encourage City Council to act decisively to allocate adequate funding in these first two, critical years of the LEC Plan to give us a strong start and keep us on track to meet our targets.

There are significant financial advantages in allocating this initial funding, as there is a strong return on investment for almost all LEC initiatives. Most of the action measures in the LEC Plan depend on critical building blocks established in early phases to capitalize on the significant cost savings from reduced energy, maintenance and operations costs for both the City and residents.

As Council moves to consider budget items over the next week, we are particularly looking forward to seeing the following initiatives funded:

- **City-wide Solar/Renewable Strategy:** This is critical to establish a long-term, comprehensive strategy for solar and renewable energy that will explore opportunities, costs, barriers to action and strategies for improvement. Once in place, the City and multiple partners can proceed to development solar and other renewable energy systems with a robust understanding of the renewable energy landscape in Saskatoon.



- **Utility Scale Solar Energy Project Implementation on Parcel M:** Council has resolved to set aside Parcel M for development of a solar plant - with a feasibility study underway, the next step is implementation. This project will contribute towards Saskatoon Light & Power's target to generate additional energy from local and renewable sources, and can demonstrate the many opportunities present in developing the renewable energy sector in Saskatoon. Long-term, the Saskatchewan Environmental Society would like to see Saskatoon Light & Power be able to construct its own wind power facilities in appropriate rural areas outside city limits.
- **Property Assessed Clean Energy (PACE) Financing Program:** We strongly support the use of PACE to incentivize existing commercial, institutional and industrial building owners to install solar systems. From our experience in working with commercial building owners in Saskatoon, solar systems on a great many existing commercial buildings are economically viable today. The primary obstacle is upfront capital cost, which PACE would help overcome. Further, PACE financing is an action measure virtually all stakeholders consulted by the City agree upon and would like to see the City pursue.
- **Community Incentive Program for Building Efficiencies, High Performance Civic Building Policy Phase I and II:** PACE Financing supports further work on building energy efficiency improvements for new and existing buildings. The Development of a High Performance Building Policy for Municipal Buildings and the application of this standard to a pilot building project, are important first steps to achieving operating cost reductions and energy savings in future builds. In the community, the Saskatchewan Environmental Society also has experience running programs to provide incentives, audits and training (such as our Energy Audit Program which can identify savings of 20-30% or our Builder Operator training program which can reduce utility costs in a building 5 to 10%). These types of programs are consistent with the method of Community Based Social Marketing, which is effective at promoting behavior change.
- **Community Electrical Vehicle (EV) Adoption Strategy:** The EV market is expected to grow significantly to 2030 and beyond, and this initiative to develop partnerships, incentive and education programming, and a robust EV charging infrastructure network is well timed. Presentations and communications to Council indicate there are potential partnership and revenue generating opportunities associated with this initiative as well.

There are several additional non-LEC items we are supportive of that are also in need of funding, such as Curbside Organics Bin Purchase and Triple Bottom Line Implementation. **We are strongly supportive of the Triple Bottom Line Implementation** as this will provide the framework to ensure decision-making across the City incorporates an understanding of financial, environmental and social impacts.
