End Student Action for a Sustainable Future program contribution*

To His Worship the Mayor and Members of City Council:

While we recognize the difficulty the City of Saskatoon (City) must be experiencing in having to make budget cuts to reduce the projected funding gap the City would face in the 2024-2025 Multi-Year Business Plan and Budget, we respectfully request that funding for the Student Action for a Sustainable Future (SASF) program remain intact. Ending this program would be a monumental loss for Saskatoon students and teachers.

SASF is an award-winning City of Saskatoon program that launched in 2013 and has been coordinated by the Saskatchewan Environmental Society (SES) since 2015. SES is a non-profit, registered charity that has been working in Saskatchewan for over 50 years. SES is seen as the leading expert in providing energy conservation resources by both educators and community organizations. SASF involves teachers and students from both the Public and Catholic divisions in **action and inquiry projects that reduce classroom, school, and household greenhouse gas emissions**. Each project results in positive reductions in the areas of energy, water, waste, food, biodiversity, and/or transportation. Over the last decade, the program has involved more than **146 teachers, 72 schools, and approximately 3,400 students** in both elementary and high schools.

SASF engages students, encourages lifelong learning, and builds strong relationships throughout the school community while achieving curriculum outcomes in many subjects. SASF builds the capacity of teachers in Saskatoon to teach and act on climate change and environmental sustainability by introducing them to the City's Strategic Plan, the City's Low Emissions Community Plan, and to community organizations that are working towards a sustainable future. SASF also helps students build **strong civic leadership skills**. This past year—in addition to all the tangible energy, water, and waste saving projects—students met with school division personnel, presented to City Council, wrote letters to businesses, and communicated sustainability goals with other students, teachers, and parents. And post-program survey responses illustrated that **79% of participating elementary school students** feel they have a positive impact on their environment after going through the SASF program.

SES would be pleased to have further discussions with the City to determine ways in which we can mutually benefit from the continuation of the SASF program in 2024-2025 and beyond. We appreciate your consideration.
