

BYLAW NO. 9920

The Zoning Amendment Bylaw, 2023 (No. 18)

The Council of the City of Saskatoon enacts:

Short Title

1. This Bylaw may be cited as *The Zoning Amendment Bylaw, 2023 (No. 18)*.


Purpose

2. The purpose of this Bylaw is to amend the Zoning Bylaw to rezone the lands described in the Bylaw from:
 - (a) an RMTN District to and an R1A District;
 - (b) an AG District to an M3 District;
 - (c) an M3 District to an R2 District;
 - (d) an IH District to an IL1 District;
 - (e) an RM1 District to an R2 District;
 - (f) an IL1 to an MX1(H) District;
 - (g) a DCD1 District to an R2 District;
 - (h) an IH District to an IL1 District;
 - (i) a site not zoned to FUD, R1A and R2 Districts; and
 - (j) an R1 District to an R2 District.


Zoning Bylaw Amended




ZONING AMENDMENT




From RMTN to R1A




ZONING AMENDMENT






From M3 to R2




From IH to IL1





From M2 to R2




From IL1 to MX1(H)
