To Rev. Fr. Herman Fields and Parish Council,

After an examination of the current condition of the Casavant organ, opus 518 in your church on October 16<sup>th</sup> 2020 and September 25, 2023, I have made some estimated costs for the renovation of the instrument. There will be two levels proposed. The first level will be to get everything working. The second level will be to get everything to function reliably and also suitable for concert performers. The estimates below are just that: estimates. If you wish to proceed, I would write up a contract for the estimated amount with a \$2,000 contingency fund for which both parties must agree in the first proposal and a \$20,000 contingency in the second proposal.

In general, the organ has many dead notes caused by various failures in the organ. In particular, there are broken and damaged pipes, dirty reed tongues, electrical problems, torn leather, sticking valves, etc. This is only an estimate. Once I get into windchests, I may find many other things that will need to be addressed in order to get everything working.

These estimates are based on doing the work with the organ residing in your church. Parts of the organ would, at times, be removed to the shop and then returned and re-installed once the work is complete on that section of the organ. Other parts of the organ would be worked on in situ. If the entire organ is going to be re-located, the cost of disassembly, crating, and moving, uncrating and re-installing (which almost always includes rebuilding framework, etc.) would be additional and would be a substantial cost, possibly doubling the cost quoted above, the amount depending on where the organ would be re-located to.
