ISSUE

BACKGROUND

Appointments are made in accordance with <u>Policy C01-003 Appointments to Civic</u> Boards, Commissions, Authorities, and Committees.

For the 2024 recruitment cycle, advertising occurred from September 9-29, 2023. Advertising was placed in the local press on September 9 and on the City's website and through the City's social media channels throughout the duration. Recruitment information was also provided to various agencies. The deadline for applications was September 29 and was extended to October 6.

Applications as in Appendices 4 were considered by the City Agency Recruitment and Evaluation Committee (CARE) in October with recommendations being made to the Governance & Priorities Committee. City Council considers appointments for Advisory Committees at its November 22, 2023 Regular Business meeting.

DISCUSSION/ANALYSIS
