BACKGROUND

The Pension Benefits Committee (the Committee) was struck in 1996, formerly as the Pension Administration Board.

The City of Saskatoon has not made appoints to its Pension Benefits Committee in several years as there was no requirement for the Committee to meet. Although it is not anticipated for the Committee to meet in the very near future, the Committee is being populated again beginning in 2024.

DISCUSSION/ANALYSIS

The Terms of Reference for the Committee is attached as Appendix 1.

The Committee reports to City Council and the Board of Trustees – General Superannuation Plan.

The functions of the Committee shall be:

- a) To review benefits available under the plan and recommend benefit improvements;
- b) To make recommendations for benefit improvements arising out of plan surpluses, which are to be made directly to Council (with a prior copy to the trustees to ensure the proposed improvements will not impair the financial integrity of the plan);
- c) To make recommendations for plan improvements not arising out of plan surpluses, which are made to the City and the employee organizations as subjects to be dealt with as part of the collective bargaining process between the parties.

The Committee has a total membership of 16 with eight being appointed/nominated by City Council and eight consisting of representatives nominated by the employee groups as follows:
