This part of Mayfair is already plagued with transient people that go through any area that is not locked in order to steal what they can. Every one of my neighbors has issues with theft and dangerous confrontations in much more regularity than should be acceptable. Most neighbors have locks on their alley gates, to help thwart some of these issues, though is still not enough.

As with every neighborhood that emergency shelters are put in, this behavior tends to increase, and would make this neighborhood unsafe and one I would not feel comfortable raising a family in.

This is now on top of the fact that city council is trying to change Avenue C to bike traffic which will take away our already limited street parking. Though I do like that the bike lanes are being put on a non-artery roadway, our parking is still important.
