We received the letter last week informing us of the new temporary shelter to be set up at 1701 Idylwyld Drive North.

WE oppose this development. We were not informed in time to understand the nature and extent of this on our office as accountants and are also in the process of renting the space.

Our building is 75% vacant, and it will be very difficult to rent going forward. Our property taxes have almost doubled in the last four years.

We did not receive any assurance where the permanent facility will be after the 18 months are over.

We are constantly trespassed by individuals, and have had our windows broken, and break-in ensued.

We fear for our wellbeing.

A proper hearing by all parties is essential to obtain assurances on our concerns.

These matters require proper input by us. We are not happy with this approach.

Kindly defer any development at this time.
