BYLAW NO. 9942

The Traffic Amendment Bylaw, 2023 (No. 5)

The Council of the City of Saskatoon enacts:

Short Title

1. This Bylaw may be cited as *The Traffic Amendment Bylaw*, 2023 (No. 5).

Purpose

- 2. The purpose of this Bylaw is to amend *The Traffic Bylaw* to:
 - (a) increase the discounted penalty for violations involving failure to pay for parking, or failure to properly display a ticket, from \$30.00 to \$35.00 and the non-discounted penalty from \$50.00 to \$60.00;
 - (b) increase the hourly parking rate from \$2.00 to \$2.50;
 - (c) add a convenience fee of \$0.15 for each parking payment made through the parking application;
 - (d) repeal the prohibition against parking at an expired parking meter;
 - (e) prohibit stopping:
 - (i) within 15 metres of a clearly marked pedestrian crossing when approaching the crossing; and
 - (ii) within 10 metres following a clearly marked pedestrian crossing;
 - (f) prohibit U-turns in school areas between the hours of 7:00 a.m. and 7:00 p.m.;
 - (g) amend the vehicle weight and size restrictions that apply to vehicles on the Traffic Bridge; and
 - (h) increase the penalty for making an illegal U-turn to \$180.00.

3. The Traffic Bylaw is amended in the manner set forth in this Bylaw.

Section 10 Amended

4. Subsection 10(6) is repealed.

Section 27 Amended

5. Subsection 27(4) is amended by striking out "area." and substituting "area between the hours of 7:00 a.m. and 7:00 p.m.".

Section 50 Amended

- 6. Section 50 is repealed and the following substituted:
 - "50. A person shall not drive or tow across the Traffic Bridge, being the bridge connecting 3rd Avenue South and Victoria Avenue, a vehicle or farm equipment that:
 - (a) has a gross vehicle weight exceeding 37,500 kilograms;
 - (b) is wider than 3.7 metres; or
 - (c) is of a height greater than 5.3 metres.".

Schedule No. 2 Amended

- 7. Subclause 1(i)(ii) of Schedule No. 2 is repealed and the following substituted:
 - "(ii) within 15 metres of a clearly marked pedestrian crossing when approaching a crossing and within 10 metres following a clearly marked pedestrian crossing;".

8. Schedule No. 9 is repealed and the schedule attached to this Bylaw as Schedule "A" is substituted.

\$100.00 plus \$20.00 for each 50 kilograms or fraction thereof by which the actual gross vehicle weight exceeds 37,500 kilograms".

(3) Section 2.1 of Schedule No. 10 is amended by repealing the following clause:

"27 Making a U-turn where prohibited \$50.00"

and substituting the following:

"27 Making a U-turn where prohibited \$180.00".

Schedule No. 9 Parking and Parking Permit Fees

Parking Fees

Parking Fees

- 1. (1) The fee for parking within a pay station zone or a ticket controlled zone is \$2.50 per hour in all areas of the City.
 - (2) A convenience fee in an amount authorized by Council may be applied to each payment for parking made through the parking application.
 - (3) Ticket dispensers and parking pay stations shall be calibrated to the fee mentioned in clause (a) and the rate shall be displayed on the ticket dispenser or parking pay station.

Parking Permit Fees

Unrestricted Parking Permit Fees

- 2. The fee for an unrestricted parking permit is:
 - (a) \$20.00; or
 - (b) \$10.00, in the case of a permit issued between May 1 and October 31 that expires in the current year.

Parking Permit Replacement Fee

3. The fee for a replacement parking permit is \$20.00.
