BYLAW NO. 9953

The Waste Amendment Bylaw, 2023 (No. 3)

The Council of the City of Saskatoon enacts:

Short Title

1. This Bylaw may be cited as *The Waste Amendment Bylaw*, 2023 (No. 3).

Purpose

- 2. The purpose of this Bylaw is to amend *The Waste Bylaw, 2022* to:
 - (a) establish a new fee structure for residential garbage collection services;
 - (b) set rates and fees for the years 2024 and 2025; and
 - (c) make minor housekeeping amendments.

Bylaw No. 9844 Amended

3. The Waste Bylaw, 2022 is amended in the manner set forth in this Bylaw.

Section 2 Amended

- 4. Section 2 is amended by:
 - (a) adding the following clause after clause (r):
 - "(r.1) "large roll-out cart" means a roll-out cart that is approximately 0.4 cubic metres in volume;";
 - (b) adding the following clause after clause (t):
 - "(t.1) "medium roll-out cart" means a roll-out cart that is approximately 0.24 cubic metres in volume;";
 - (c) repealing clause (cc) and substituting the following:

- "(cc) "roll-out cart" means an approved container on wheels, designed for automated collection, that is a small, medium or large roll-out cart;"; and
- (d) adding the following clause after clause (dd):
 - "(dd.1) "**small roll-out cart**" means a roll-out cart that is approximately 0.13 cubic metres in volume;".

Section 12 Amended

- 5. Section 12 is repealed and the following substituted:
 - "12. (1) No person shall place waste in a waste container other than the owner or occupant of the property to which the waste container is assigned, or a person with permission of the owner or occupant.
 - (2) No person shall move or otherwise handle a waste container on a public right-of-way other than:
 - (a) the owner or occupant of the property to which the waste container is assigned, or a person with permission of the owner or occupant;
 - (b) a person authorized by the General Manager; or
 - (c) for the purposes of returning the waste container to an upright, proper position on the public right-of-way.".

Section 24 Amended

6. Subsection 24(1) is amended by adding "garbage" after "provided".

Section 26 Amended

- 7. Section 26 is repealed and the following substituted:
 - "26. (1) Where automated collection from roll-out carts is in effect, each dwelling unit shall, subject to any cart sharing between dwelling units that may be approved by the General Manager for garbage, be provided with the following roll-out carts for the sole use of the owner or occupant of the dwelling unit:

- (a) a roll-out cart for garbage;
- (b) a roll-out cart for organic material;
- (c) a roll-out cart for recyclable material.
- (2) A person may, subject to payment of the applicable fee set out in Schedule "D" and in accordance with the requirements of the General Manager, apply for the following:
 - (a) to change the size of their roll-out cart for garbage to a small, medium or large roll-out cart;
 - (b) an additional large roll-out cart for garbage.
- (3) The General Manager may:
 - (a) select the default size of a roll-out cart that is to be provided to a dwelling unit pursuant to subsection (1); and
 - (b) at any time substitute a dwelling unit's roll-out cart for a larger roll-out cart if the General Manager is of the opinion that the dwelling unit's current roll-out cart is of insufficient volume to adequately contain the dwelling unit's garbage.
- (4) Roll-out carts provided to a dwelling unit shall not be refused, removed or used by any person for any purpose except as permitted in this Bylaw or as otherwise permitted by the City.
- (5) Persons who are low-income, as determined by the City, may be eligible to participate in any program the City may offer to subsidize the costs of garbage collection services."

Section 27 Amended

8. Subclause 27(a)(i) is amended by striking out "1.3" and substituting "1.2".

Section 66 Amended

- 9. Section 66 is repealed and the following substituted:
 - "66. The City may, in accordance with section 333 of *The Cities Act*, add to the tax roll of a parcel of land any unpaid:

- (a) expenses or costs incurred by the City in remedying a contravention of this Bylaw; and
- (b) charges for garbage, organic material or recycling collection services."

Schedule "D" Amended

10. Schedule "D" is repealed and the schedule marked as Schedule "A" to this Bylaw is substituted.

Schedule "E" Amended

- 11. Section 1 of Schedule "E" is amended by adding the following section after section 1:
 - "1.1 Notwithstanding section 1, the fee set out in Schedule "D" applies to dwelling units receiving curbside residential garbage collection services that have an additional large roll-out cart for garbage."

Coming Into Force
