Thank you for the opportunity to speak.

Saskatoon Cycles is firmly in support of the motion to reduce vehicle speed to 30 kms on roads designated as neighborhood Bikeways. We feel that reduced speed is a significant factor in reducing harm to active transportation participants, like cyclists, by:

discouraging high volume and speed of vehicular traffic creating a more welcoming and inviting environment for cyclists giving all parties more time to react to the unexpected, allowing all parties to see each other well in advance, and mitigating, in the worst case scenario of a collision, the severity and extent of injury.

SGI President and CEO Penny McCune is quoted on the SGI website: "The faster you speed, the less time you have to react. And if a collision does happen, higher speeds equal more damage and a greater risk of injury and death."

We believe that along with proper enforcement and appropriate traffic calming measures, a 30km speed limit on Bikeways will contribute to rider comfort, increased active transportation use, and overall better safety outcomes.

We strongly endorse this proposal, and would be happy to advocate on its behalf at any future point of consideration.
