I believe dedicated bikeways would make the City of Saskatoon a much safer, healthier and sustainable city.

I bike to and from work and my daughter bike to and from school on a daily basis. We both use McKinnon Ave. This street would be a natural bikeway as it goes through several neighbourhood and passes several schools and parks on its way to the University of Saskatchewan.
