**Comments:**

I am writing to express my support for both the proposed reduced speed limit on neighbourhood bikeways and the Ave. C corridor.

I am a regular commuter and recreational cyclist and I am in strong support of any and all efforts for improved cycling infrastructure across the city. These are efforts that will improve safety and usability for every active transportation user in the city.

Reduced speed limits on designated cycling routes are particularly important. Vehicles can be very intimidating, particularly to novice cyclists, and reducing traffic speed on these routes is absolutely critical to creating an inviting and comfortable cycling experience. I have had many experiences cycling with my children on neighbourhood streets where a vehicle moved far too fast and far too close to an obviously wobbly child. This kind of experience reduces a child's enthusiasm for cycling and delays their skill development - remember that a novice cyclist will only become a confident experienced cyclist if they have a place to safely learn. Lets create an environment where kids can learn how to ride on a street safely.
