Dear Mayor Clark and City of Saskatoon Councillors,

My name is Julia Boughner, a constituent of Ward 6 (Buena Vista).

Thank you for the work that you have been doing to mitigate the drivers of global heating and to build the City of Saskatoon's resilience in the face of the climate crisis. I value the City's actions, including the Net Metering program, which my household has participated in since our solar panels were installed in 2016.

However, further to the City's current *Climate Action Plan*, I'm writing to express my deep concern over the possible cuts and delays that are being discussed in the upcoming multi-year budget for our city.

As recent extreme climate events, including droughts and forest fires, are showing clearly, we live in a time when further delay of climate mitigation is unacceptable and irresponsible – and not a little terrifying if I am being honest, when I think about the future for my family and community.

For the 2024-2025 budget, funding towards Saskatoon's Climate Plan and beyond needs to be made a top priority because to do otherwise places residents' wellbeing and livelihoods at risk.

I know that climate change will impact Saskatoon. As a citizen, I want my city councilor to support and fund programs, services and initiatives that will fight the climate crisis. I've come to rely on City services, such as sustainable transportation, renewal energy, community gardens, green infrastructure, and forest protection. I want to see these and other initiatives, services and projects that lower emissions – such as improved public transportation, public EV charging stations, and library services – funded and prioritized.

I hope that during the next budget meeting on August 15 and in the November budget meeting, strategies outlined in the City of Saskatoon's Climate Plan are prioritized and not considered for austerity measures.

Councillor Block, I hope you will represent these views during the budget discussion, as a councillor who both represents the desires and needs of the Ward 6 community as well as protects and secures its future.
