The Saskatchewan Environmental Society (SES) recognises the complex ongoing discussions regarding the City's 2024-2025 Business Plan and Budget. With that in mind, we'd like to reiterate the need to continue funding Saskatoon's Low Community Emissions Plan and the goals and projects within the City's Climate Action Plan.

Every one-tenth of a degree rise in global average temperature that can be prevented will make a positive difference to the next generation. We owe it to our children and grandchildren and all future generations to do everything we can over the next decade to address the climate emergency and to set the stage for achieving carbon neutrality by 2050.
