Dear Mayor & Council,

I have been on the record over the years speaking and writing to Council and councillors about environmental and transportation initiatives, and in support of specific initiatives like the Low Emission Community Plan, the Bus Rapid Transit plan, and the Active Transportation plan, among others. I understand that the city is facing a budget shortfall, to a large extent due to inflationary pressures and a lack of outside funding support, e.g. from the province. As Council works to navigate this reality, I write today to urge you not to cut costs associated with the above-mentioned initiatives. Importantly, many of these are long-term cost-saving measures, and it would be extremely short-sighted to cut environmental programs to address immediate budgetary concerns when they will no doubt save the city money over the years to come. And, beyond monetary concerns, initiatives like the LEC Plan are critical for Saskatoon to play a meaningful role in addressing climate change, which is a moral imperative and extremely important to so many in this city. Again, I urge you not to try and address immediate budget shortfalls by cutting on environmental and transportation initiatives that are going to help modernize this city, and help us all adapt to this changing climate.
