While we understand that cuts are necessary, we believe that targeting these expenditures represents false economy.

1. The City's cash grants elevate and enhance the contributions of volunteers. As an organization that has occasionally benefited from the City's Environment Grant, we know that the return on investment is many hundred-fold, unleashing contributions of time, energy and expertise that the City could not otherwise afford. In times of austerity, programs that help the City reach its goals at minimal cost should be protected, not cut.

Page 69 of the draft Operating and Capital Budget notes an increase of \$9200 to the Environmental Cash Grant "to account for program growth." However, we understand that this represents a reallocation of funds rather than an increase in the pool of money that is actually available to support community initiatives. To begin "to account for program growth," we ask you to reinstate the small increases noted above and allocate them to the Environment Grant, to bolster the City's progress toward its sustainability goals.
