Comments:

To Saskatoon City Council,

The board of Saskatoon Cycles has long advocated for a legal pedestrian/cycling crossing at the CN tracks between Millar Avenue and Assiniboine Drive.

This absent piece of infrastructure has been pointed out for years as highly problematic for the thousands of people who live near, visit, or work in the North Industrial section as there is currently no legal way to cross these tracks as a pedestrian or cyclist from 33rd Street to 51st Street.

Imagine a concrete wall spanning 3.5 km that ran through major neighborhoods and featured only a single passageway, and that passageway was exclusive to motor vehicles. We might suggest that this would not be the design of a city committed to active transportation, yet that is the legal reality faced in Saskatoon's north end by anyone getting around by foot or bike.

The implications of this are myriad and significant:

It is inequitable. The lack of access is a particular barrier to anyone without the means of vehicle ownership. It is inconvenient. The forced detouring from an obvious crossing discourages active transportation use by those who might otherwise choose a healthier option.

It is unsafe. The current lack of a legal, codified crossing invites users to cross at random points of their own choosing.

To his credit, Councilor Randy Donauer (Ward 5) has been working on this file for years, navigating both City of Saskatoon and CN Rail processes to address the concerns of the community. We acknowledge and applaud any and all efforts that have been made to this point; we are told that these types of infrastructure projects involving private companies can be very complicated, and likely not made easier with budgetary pressures.

Still, we must insist that more be done.

At the REGULAR BUSINESS MEETING OF CITY COUNCIL Wednesday, November 22, 2023 the following recommendation was approved and forwarded for budget deliberations:

RECOMMENDATION: That the Assiniboine Drive CN Rail Pedestrian Crossing project be forwarded to the 2024/2025 budget deliberations for funding consideration within the Capital Business Plan Options. RATIONALE: The following was considered in developing the recommendations:

It allows the project to remain viable, thus potentially addressing the safety issue of not having a formal pedestrian crossing of the CN rail near the intersection of Assiniboine Drive and Warman Road.

If funded for 2024/2025, the project can be completed for the updated budget amount, whereas if it is deferred, further inflationary increases would likely occur.

A comparison with, and discussion about, other City initiatives and needs is enabled.

Saskatoon Cycles cannot stress urgently enough the importance of this crossing to meaningfully and safely connect neighborhoods in the north end, and we therefore strongly support proper funding being provided during these budget deliberations.
