Dear Mayor Clark and Councillors,

My name is Mackenzie Burnett. I am writing as a resident of Ward 6 to personally express my concern about the proposed spending cuts related to the Transportation and Environmental Health Business Lines in the City of Saskatoon's 2024-2025 Business Plan and Budget. I understand that you are working to decrease the deficit, but I ask that you not cut spending on Transportation, Environmental Health, or the Climate Action Plan. By spending strategically today, you can help safeguard the health, safety, and prosperity of Saskatonians in years to come.

I invite you to recall the 2021 Western North American heat wave, during which record temperatures endangered people throughout western Canada and the United States. I was working remotely from Alberta at the time, while my boss lived and worked in Saskatoon. She is a healthy woman in her forties, but collapsed in her home when she overheated. Her son found her and had to call her an ambulance. Fortunately, she recovered quickly.

I invite you to reflect on the 2023 fire season, which has destroyed an unprecedented amount of land and infringed on the safety of thousands. My parents in Edson, Alberta had to evacuate twice before the end of June due to encroaching fires. Each time, they left not knowing whether they would see their home again.

I also invite you to think about the smoke that has lingered over the province this summer. I have been conducting research in northern Saskatchewan since May, and have seen the smoke have a noticeable impact on health and productivity. My colleagues and I have had to go home early on several occasions due to experiencing headaches and shortness of breath. How has the smoke affected you?

As you can see, climate change is already affecting the health, safety, and prosperity of people in Saskatoon and throughout the world. We cannot afford to delay climate change mitigation and adaptation any longer. I hope you will keep this in mind as you develop the 2024-2025 Business Plan and Budget. Again, I ask that you not cut spending on Transportation, Environmental Health, and the Climate Action Plan. Instead, I ask that you sufficiently fund these areas so that we may meet the commitments the City of Saskatoon has made and protect the health, safety, and prosperity of current and future generations. Thank you for all the work you have already done on this important issue.
