

BYLAW NO. 9956

The Street Closing Bylaw, 2024

The Council of The City of Saskatoon enacts:

Short Title

1. This Bylaw may be cited as *The Street Closing Bylaw, 2024*.

Purpose

2. The purpose of this Bylaw is to close a portion of lane adjacent to 1902, 1904, 1908, 1910, 1912, 1914, 1918 and 1922 20th Street West and 215 Avenue S South, Saskatoon, Saskatchewan.

Closure of Portion of Lane

3. All those portions of lane, more particularly described as:

All that portion of St/L 9 on Plan G3978 in the NE ¼ of Section 30, Township 36, Range 5, West of the 3rd Meridian as shown on the Sketch Showing Proposed Road Closure prepared by Meridian Surveys Ltd. dated November 16, 2023;

and attached as Schedule “A” to this Bylaw, is closed.

Authorization to Carry Out Bylaw

4. The Mayor and City Clerk are authorized to execute all such documents as may be necessary to carry out the intent of this Bylaw.

5. This Bylaw shall come into force on the day of its final passing.
