Saskatoon Cycles supports the proposed item to connect the 33rd Street Shared-use Pathway to the future 31st Street Bikeway.

We are committed to advocating for a safe city for all road users, using all modes of transportation, and we feel this kind of connective piece of infrastructure is an important component in achieving this goal.

Saskatoon Cycles wants to see a baseline network of safer, continuous, and connected active transportation routes, free of gaps and danger zones, maintained appropriately, linking common Saskatoon destinations. The item standing for vote is *precisely* the kind of development that will provide greater access and safety to all mobility modes, with minimal interference to the current infrastructure.

We endorse this proposal, and urge council to vote for its adoption. We further encourage administration and council to expand these kinds of projects as quickly as possible to create the baseline network that will improve the transportation landscape for all road users.
