Title

1 These regulations may be cited as *The Local Government Election Amendment Regulations*, 2023.

- "(3) For the purposes of section 47.1 of the Act, an emergency is a situation in which the health or safety of persons is at risk, and may include:
 - (a) severe weather;
 - (b) a declared state of emergency; or
 - (c) a public health order preventing the movement or assembly of voters".

 - (a) subject to subsection (1.2), a voter's registration form completed by the person requesting a mail-in ballot;
 - (b) a declaration signed by the person requesting a mail-in ballot that includes:
 - (i) a statement that the person is qualified to vote in the municipality;
 - (ii) evidence of the person's identity as set out in section 110 of the Act; and

- (iii) a statement that the person believes the declaration to be true and knows that it is of the same force and effect as if made under oath or affirmation and by virtue of the *Canada Evidence Act*.
- "(1.1) The declaration mentioned in clause (1)(b) may be made:
 - (a) in person before the returning office or other person authorized by bylaw or resolution to witness the person's signature; or
 - (b) by registered mail, by ordinary mail, by fax, by email or as otherwise specified in the bylaw or resolution, in which case the declaration must be accompanied by:
 - (i) the person's signature; and
 - (ii) copies of the identification or information provided for the purposes of subclause (1)(b)(ii).
- "(1.2) A person requesting a mail-in ballot is not required to complete a voter's registration form if:
 - (a) a voters list is being used in the election; and
 - (b) the information provided in the person's declaration made in accordance with subsections (1) and (1.1) matches the information in the voter registry respecting that person".

- **35**(1) For the purposes of clause 53.5(1)(a) of the Act, a person or a person's agent may apply to have access to information in the voter registry about the person by providing the returning officer with a request, in writing, that contains the following information:
 - (a) the person's full legal name;
 - (b) the date of the request;
 - (c) the person's ordinary residential address;
 - (d) if submitted by the person's agent, the agent's full legal name and mailing address; and (e) either:
 - (i) the signature of the person making the request; or

- (ii) if submitted by the person's agent, a declaration signed by the agent stating that the agent is authorized to make the request on the person's behalf.
- (2) For the purposes of clause 53.5(1)(b) of the Act, a person or a person's agent may apply to have the person's information removed from or not included in the voter registry by providing the returning officer with a request, in writing, that contains the following information:
 - (a) the person's full legal name;
 - (b) the date of the request;
 - (c) the person's ordinary residential address;
 - (d) the person's mailing address if different than the address mentioned in clause (c);
 - (e) if submitted by the person's agent, the agent's full legal name and mailing address;
 - (f) a statement of confirmation that the person's information is to be removed from or not included in the voter registry;
 - (g) a statement of recognition that, if the person's information is removed from or not included in the voter registry:
 - (i) the person's name will not appear on the voters list for municipal and school board elections; and
 - (ii) the person will be required to register at the poll in order to vote; and
 - (h) either:
 - (i) the signature of the person making the request; or
 - (ii) if submitted by the person's agent, a declaration signed by the agent stating that the agent is authorized to make the request on the person's behalf".

- **40** The returning officer shall ensure that a poll book or advance poll book, as the case may be:
 - (a) numbers each voter sequentially; and
 - (b) contains the following information for each voter:
 - (i) the voter's name;
 - (ii) whether the voter was issued a ballot with respect to the election of any of the following:
 - (A) the mayor or reeve;
 - (B) a councillor;
 - (C) a member of a public school board of education;
 - (D) a member of a separate school board of education;
 - (E) a bylaw, resolution or question; and

- (iii) in accordance with subsection 112(1) of the Act:
 - (A) whether a candidate or a candidate's agent objected to the voter's eligibility to vote; and
 - (B) the name of the person who made the objection".
