

## **BYLAW NO. 9965**

### **The Saskatoon North Partnership for Growth Planning District Official Community Plan Amendment Bylaw, 2024 (No.2)**

The Council of the City of Saskatoon enacts:

#### **Short Title**

1. This Bylaw may be cited as *The Saskatoon North Partnership for Growth Planning District Official Community Plan Amendment Bylaw, 2024 (No.2)*.

#### **Purpose**

2. The purpose of this Bylaw is to amend The Saskatoon North Partnership for Growth Planning District Official Community Plan to remove land from the Future Urban Growth Areas.

#### **Bylaw No. 9720 Amended**

3. The Saskatoon North Partnership for Growth Planning District Official Community Plan, being Schedule “A” to Bylaw No. 9720 and forming part of that Bylaw, is amended in the manner set forth in this Bylaw.

#### **Future Urban Areas Growth Map Amended**

4. The Future Urban Growth Areas Map, which forms part of the District Official Community Plan as Schedule C, is amended by removing the lands from the area of Growth to 1,000,000 described in this Section, and shown on Schedule “A” to this Bylaw as follows:

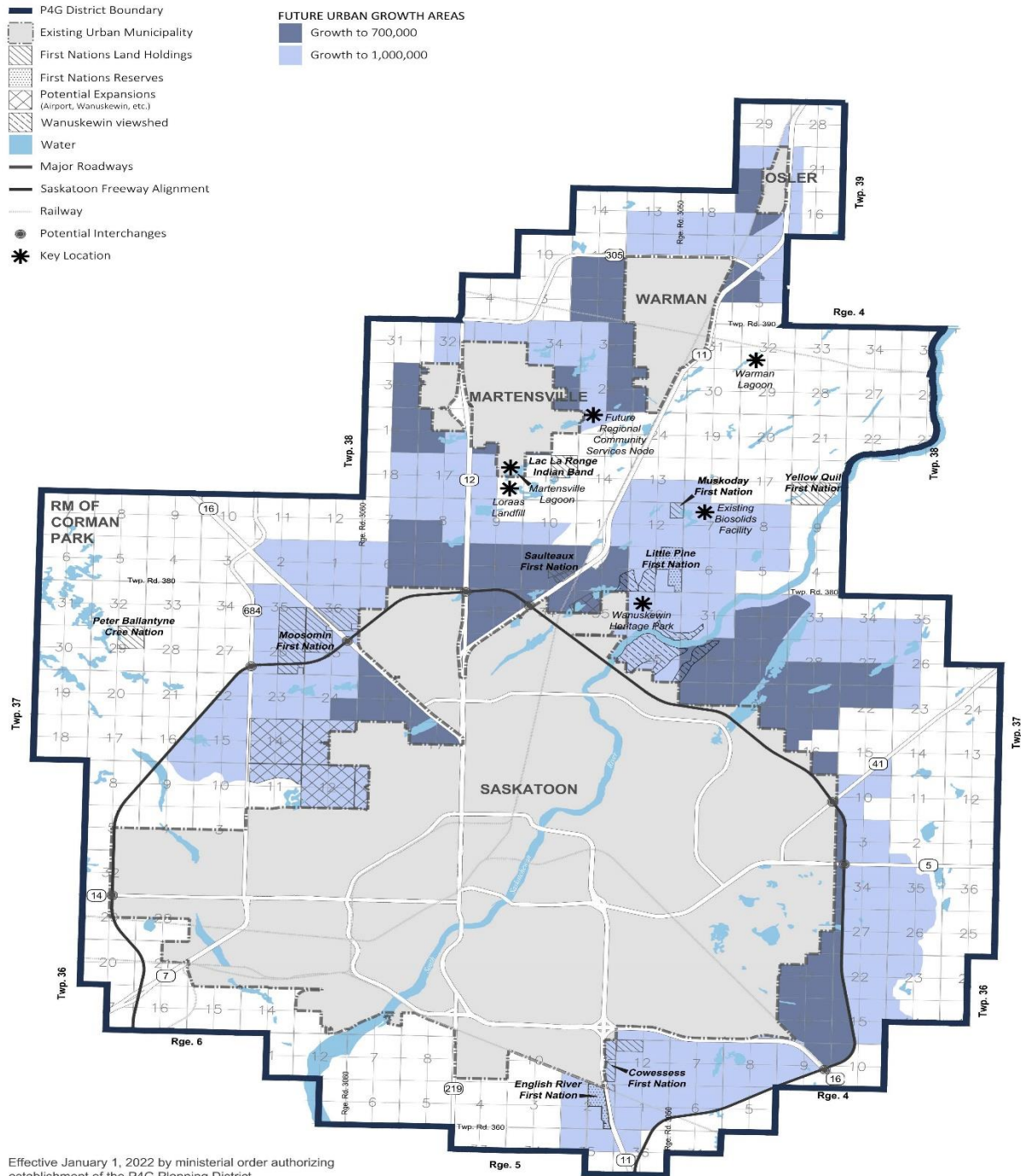
