Re: Broadway Business Improvement District 2024 Budget

Please find attached the 2024 budget for the Broadway Business Improvement District (BBID), which was approved by the Board of Directors on January 11th, 2024 for submission to the City of Saskatoon.

For 2024 the BBID Board is requesting an increase to the levy of 2% to keep up with inflation and the additional work the BBID is planning for 2024. This will raise the contribution to \$207,945 from \$203,868, an increase of \$4,077.

The BBID is planning for two large sidewalk sale events in 2024 and supporting other festivals in the area including 25th St Theatre, The Saskatchewan Jazz Festival, Etsy Fair, Nuit Blanche Saskatoon, Winterruption, Word on the Street, BreakOut West and more.

Other areas of focus in 2024 will be a large public art installation, art pieces including painted crosswalks, continued expansion of special event offerings, networking and workshop opportunities for merchants, increased marketing and continuation of grants to members,

We look forward to another colourful, lively year on Broadway!
