Re: SPC Transportation, February 6, 2024, Agenda item 7.2.2 Saskatoon Freeway Planning Study Endorsement Request

The Northeast Swale and Small Swale are both ecologically sensitive areas of endangered grassland within our city that are not only valuable to the land and the ecosystems it connects to, but to the people of this city. This was evident last year, when council addressed the swale boundaries, by the 7 speakers that presented and amazing 42 letters written, including one from the Swale Watchers that was supported by 12 local and provincial organizations, to protect as much of these Swales as we could. Citizens of Saskatoon care about the Swales and want to see them conserved. These Swales can also pave the way for our National Urban Park.

The proposed freeway threatens the ecological integrity of the Swales by forcing a minimum of 8 lanes of high-speed traffic through both areas, causing irreversible damage. These impacts include ecosystem fragmentation, habitat loss, damage and degradation of wetlands, and noise and light pollution. Increased fragmentation of the area makes it difficult for wildlife to pass through and around our city and can make it more difficult and less enjoyable for recreational walking of the area too. Habitat loss (to development) is the biggest issue faced by already endangered grasslands and is made worse when there are species at risk in that ecosystem. Wetlands provide numerous environmental services just by existing, including water filtration and improving water quality, maintaining surface water flow (evening out flood and drought), and carbon storage. Noise and light pollution not only disturb wildlife but also people living near these large scale projects.

The disadvantages of this freeway development are quit evident, and it does not align with the City's Triple Bottom Line, Green Infrastructure planning, and the hope of having a National Urban Park in Saskatoon. You, as councillors, have listened to concerned citizens before and made the right decision to protect the Swales and can easily do it again by not endorsing this Phase 2 of the Freeway and consider a further educated decision of looking at the impacts this development will have on the Northeast and Small Swales and other environmentally sensitive assets.
