Members of Saskatoon City Council,

I have been a resident of Saskatoon for over 50 years, and a resident of Saskatchewan all my life except for 5 years studying in the USA.

I grew up in an era where the prevailing North American world view was that fresh water was free or almost so, where the natural environment was there to be exploited, that the climate was something that was impervious to human activity, and energy for transportation, home heating and electrification was very affordable.

Sadly, many people still think that way, with the exception of rising energy costs. Political leaders at all levels now have the difficult challenge of explaining to the electorate that we must change our ways, including the need to pay for correcting past mistakes.

Saskatoon is a very desirable place to live. We have many 'big city benefits' while yet remaining a community that allows access to a healthy life style that is not found in much larger centres. I spent 5 years in the Los Angeles area where air pollution, lack of green space and long commute times were 'normal'. Many children never, or rarely, saw a forest or a wild species.

One of the most unique and desirable features of our city is the presence of green space, including natural prairie, within city limits. Few places in the world can boast of that. I feel very strongly that it is incumbent upon our city to protect and preserve those spaces for recreation, education and opportunities for healthy living within access to the natural world.

## I urge Council to reject the plan for Phase 2 of the proposed Saskatoon Freeway and request the Province to collaborate on a thorough study of options for that project that avoid the devastating impact on the Northeast and Small Swales.

Many people do not appreciate the challenges faced by members of a City Council; I do. I have great appreciation and respect for the work that you do on behalf of our city. I especially appreciate that it takes real courage to make difficult decisions. Saying no to the proposed plan will no doubt displease the Ministry of Highways, **even though their own studies confirm the worst fears about the potential impact on the two Swales**.

I hope you will take a stand in favour of protecting an irreplaceable asset to our city. Future generations will thank you for it.
