## **BYLAW NO. 9984**

## The Zoning Amendment Bylaw, 2024 (No. 6)

The Council of the City of Saskatoon enacts:

#### **Short Title**

1. This Bylaw may be cited as *The Zoning Amendment Bylaw, 2024 (No. 6)*.

## **Purpose**

- 2. The purpose of this Bylaw is to amend the Zoning Bylaw to rezone the lands described in the Bylaw from:
  - (1) an R1A District to an R2 District;
  - (2) an R1B District to an R1A District;
  - (3) an R1B District to an R2 District; and
  - (4) an R2 District to an R1A District.

## **Zoning Bylaw Amended**

3. Zoning Bylaw No. 8770 is amended in the manner set forth in this Bylaw.

#### R1A to R2
