To: Saskatoon City Council,

My name is Lavinia Cheng and I am a Grade 8 student from EcoQuest, I enjoy biking and want to create a safe environment for other cyclists out there, especially those who aren't used to biking on roads, or are young and haven't received the proper training to be able to bike in places that currently aren't so safe.

Biking in winter is hard, especially in such cold areas we live in the world, I recall multiple times when trying to bus with a bike was a challenging experience, with many different notable obstacles such as:

- Not enough places to put your bike (a max amount of 2 people)
- A generally negative attitude toward cyclists asking if they could put their bike on the bus (which could be understandable if the bus were quite full)
- Also not enough storage space for different kinds of bikes on the racks (most bikes have tires that can't fit on the racks)
- Busses sometimes ignore cyclists at bus stops and drive off without stopping (me and my classmates have had a few incidents like this happen)

Although these problems wouldn't be as awful during the warmer months of the year, it's really rough during the colder months, especially if you're standing outside at -40 waiting for the next bus, only for the racks to be frozen shut, then asking if you could put your bike on the bus and the driver not complying to your request. Winter biking is undoubtedly dangerous (multiple life-threatening situations such as falling off your bike in the middle of the road because of ice, frost bites from waiting at the bus stop with your bike, and many more other situations you may find yourself in if you're winter-biking), which is why it's important for us and everyone else to start fixing these problems.

I want to talk about a friend in my class. Enoch O'soup is a quiet and kind kid, and recently he got tragically hit by a car while he was winter biking. We were all shocked and saddened by the news, thankfully he came back the next day miraculously without a scratch. But this incident led me to start thinking more about bike safety and winter biking, which is why I am writing this letter to you. I want to protect more kids like Enoch who might be winter-biking or just biking normally from the dangers on the road.

Not only that, but we should also strive to educate cyclists, young and old. Before EcoQuest, I had absolutely no idea that I could put my bike on the rack in front of the bus, if I did I'm sure it would have proven useful in my years as a cyclist. We could put instructions on how to put your bike on the racks on the bike map, and we could also put bus stops on the map that can be of use in case you need to get on one.

There are multiple solutions to these problems as there always are, so I hope you can find it in you to read and consider this letter with a great deal of importance.
