However, this intersection being a problem is not new information, so it's surprising to me that more specific cycling measures aren't being supported now (Nos. 8-10). Implementing 9 and 10 as soon as possible only makes sense. In the meantime, a painted bike box and lane, and no turn on red, (No. 8) would go a long way to making Wiggins safer.
