.1.1 Julia Adamson – Friends of the Saskatoon Afforestation Areas Inc. – Proclamations Limited to One Per Year for Organizations [GPC2024-0305]

On behalf of the Friends of the Saskatoon Afforestation Areas, I extend my sincere gratitude to Cindy Yelland, City Solicitor, Adam Tittemore, City Clerk, and Jeff Jorgenson, City Manager, for their attention to our query of March 13, 2024, regarding Policy No. C01-028, The Flag and Proclamations Policy.

We stand behind the options presented by administration for approval and urge the Committee to consider voting in the affirmative for Option 2 or 3, preferably Option 3 for the betterment and enhancement of our community.

Option 2 proposes to increase the limit on the number of permitted proclamations per organization per calendar year from one to two (or any other number). This option maintains some limit on the number of proclamations while increasing the allowance, thus providing organizations with more opportunity to bring attention to important matters in our community.

Option 3 suggests removing the limit entirely, allowing organizations to make unlimited requests for proclamations. While this option would increase the workload for the City Clerk's Office, it would also provide organizations with the flexibility to advocate for various causes throughout the year.

We believe that either option would mitigate the dilemma of legal action and criticism levelled against municipalities for issuing proclamations in recognition of some causes and not others. By allowing organizations to present their own proclamations in alignment with proclamation bylaws, we can foster inclusivity and address concerns regarding fairness and equity.

Furthermore, we suggest that on the City of Saskatoon policy website, a sample format for protocol submissions could be added <u>similar to this one</u> for edification to groups considering submissions. This would provide clarity and guidance to organizations seeking to request proclamations, ensuring adherence to established protocols, Policy No. C01-028, and standards within the community, This would facilitate the work of the City Clerk's Office.

In our previous letter to the Governance and Priorities Committee on March 13, 2024, we highlighted the importance of proclamations in bringing attention to significant events and initiatives within our community. We firmly believe that the proposed changes to the Flag and Proclamations Policy will enable organizations across our amazing city to continue supporting important causes and events in Saskatoon.

We appreciate your consideration of this matter and look forward to seeing positive changes that will benefit our community as a whole. Thank you for your dedication to enhancing the civic and cultural life of Saskatoon.

Below is the sample proclamation letter for the ParticipACTION Community Challenge Saskatoon ParticipaCTION Community Challenge Month of June Proclamation

Reason 1: WHEREAS, Get ready to participate this June to get active, connect with others and help your community be crowned Canada's Most Active Community and win \$100,000 to support local sport and physical activity initiatives!

Reason 2: WHEREAS, The ParticipACTION Community Challenge is a national physical activity and sport initiative that encourages everyone in Canada to get active throughout June in search of Canada's Most Active Community.

Reason 3: WHEREAS, the ParticipACTION Community Challenge affords weekly prizes to celebrate and recognize participating organizations, and amazing incentives to participate as an individual.

Reason 4: WHEREAS, Everyone in Saskatoon should have access to quality recreation, sport and physical activity opportunities that help them grow and thrive—physically, emotionally, and socially, including equity-deserving groups in particular Black, Indigenous, racialized, 2SLGBTQQIA+, persons with varying abilities, low-income populations and newcomers to Canada. Such a campaign levels the playing field by reducing barriers to recreation, physical activity, and sport and building stronger and healthier communities.

Reason 5: WHEREAS, Friends of the Saskatoon Afforestation Areas has as its motto "Come to Nature, Come to Life!"

Reason 6: WHEREAS, we aim to honour Professor Emeritus Don Bailey, Father of the College of Kinesiology and Father of ParticipACTION Canada, and the late Professor of Radiology George Genereux, friend of Saskatoon, and Olympic gold medalist and namesake of an afforestation area

Alternatively each instructor could register their "class" as a "group or organization" and do their own head count to be eligible for the weekly prizes. Additionally, could the Parks Department forward our contact information or send their own email blast to encourage registration by sports groups and individuals who use the sports fields / facilities of Saskatoon?
