Below are comments regarding the city's efforts to improve the safety and accessibility for modes of active transportation. As the climate crisis worsens, citizens are going to increasingly need to rely on non-vehicle forms of transportation, so I believe improving cycling in the city is very important.

Regarding item:

Connecting 2nd Avenue/3rd Avenue: Walking, Cycling, and Driving Improvements, I support Option 2A – Widen to the West.

I am in favour of improving this street to make it safer for pedestrians and cyclists. I support the use of pedestrian actuated signals and a separated shared-use path.

Regarding item:

Opportunities for Rapid Deployment of Safety Improvements on Active Transportation Route, I support Option 2: Implement a Neighbourhood Bikeway using Rapid Deployment on Route 6.

I am in favour of a bikeway along Route 6/Munroe avenue. I regularly use these types of routes in other areas of the city when commuting by bike around the city, and I find these are much safer when I can cycle without needing to share the streets with many vehicles.
