To the Standing Policy Committee on Transportation,

Cities should allow all citizens to move safely from neighborhood to neighborhood regardless of their mode of transportation. Expanding the network of safe routes, where everyone can get around in a safer manner, is important.

Before you are two items of business that I believe will help in this regard.

Regarding item:

7.1.1: Connecting 2nd Avenue/3rd Avenue: Walking, Cycling, and Driving Improvements [TS2024-0504], I support Option 2A – Widen to the West.

I feel that pedestrian actuated signals and a separated shared-use path are great features that will enhance this area of the city and make it much safer for pedestrians and cyclists.

Regarding item:

7.1.2: Opportunities for Rapid Deployment of Safety Improvements on Active Transportation Routes – May 2024 Update [CC2023-0602, TS2023-1003, TS2023-1204], I support Option 2: Implement a Neighbourhood Bikeway using Rapid Deployment on Route 6.

I believe a bikeway along Route 6 (Munroe Avenue) would offer more access to campus for active transportation users with a wider range of abilities and theoretically could reduce University traffic congestion in general, and at College and Wiggins in particular. My husband is a professor at the U of S and cycles to work daily all year round. I use this route as well but I am also an avid year round cyclist that uses these routes.
