

8.1.2 Small Swale and Richard St Barbe Baker Afforestation Area – Natural Area Management and Conceptual Plans

We are grateful to the members of the SPC on Environment Utilities and Corporate Services for requesting additional information to support Council's discussion of this item.

The maps provided at their request – 12. Small Swale Ecological Extent and 13. Small Swale Related Boundaries – provide a clear picture of what has been accomplished and what remains to be done. The Small Swale is a connected corridor of grassland and wetland habitat, and much of its ecological significance depends on its wholeness. Planning to manage a fragment of this feature is a step in the right direction, but it is just the beginning.

We look forward to a future Management Plan that fills in the gap between the current document and the proposed provincial Freeway and extends north to embrace the Small Swale as a whole. This will include areas that fall within the viewscape of Wanuskewin, as indicated on the P4G land-use map (attached to your agenda as Appendix 3 to item 10.1.1.) It is worth noting that, although portions of the Swale are currently outside City limits, much of the land is already in City ownership, as shown in green below.¹
