## Comments:

Dear Council,

I'm writing with two requests, that Council:

1. Vote NO to the Phase 2 Proposed Saskatoon Freeway alignment through the Northeast and Small Swales.

2. Live up to their commitment to protecting these natural areas.

The Phase 2 Functional Design Report and Phase 2 Biological Assessment make it clear that it's impossible to route the proposed freeway in a way that avoids substantial irreversible damage to the swales. The proposed routes would destroy a large portion of the remaining habitat for rare and endangered species of animals and plants.

This is a result of the parameters set by the Province for Phase 2. The City should demand that the Province provide an alternate, better plan. I know that a lot of effort and expenditure has already been put into planning Phase 2 of the freeway, but it would be irrational to to stay with a bad plan based on sunk costs. It's never the wrong time to make the right decision.

I grew up in Saskatoon, moved away for about twenty years, and moved back to Saskatoon a little over ten years ago. When I was young, I was struck by the beauty of the small amount of natural prairie that remained in the Saskatoon area. Now those natural areas have become even fewer and smaller. The other cities I lived in had the foresight to preserve large natural areas. Having these natural areas greatly enhances the quality of life in a city. In the case of provincial freeway planning, I hope Saskatoon will push the Provincial government to have the same foresight.
