

# BYLAW NO. 9996

## The Street Closing Bylaw, 2024 (No. 2)

The Council of The City of Saskatoon enacts:

### Short Title

1. This Bylaw may be cited as *The Street Closing Bylaw, 2024 (No. 2)*.

### Purpose

2. The purpose of this Bylaw is to close a portion of lane adjacent to 229, 231, 233, 235, 239, 241, 303, 305, 307 and 309 11<sup>th</sup> Street East and 222, 230, 306, 310 and 316 Saskatchewan Crescent East, Saskatoon, Saskatchewan.

### Closure of Portion of Lane

3. Pursuant to clause 8(1)(g) of *The Cities Act*, the portion of the lane, more particularly described as:

All that portion of Street St/L 4 shown on Registered Survey Plan K510 & all that portion of Street St/L 1 shown on Registered Survey Plan A7252, both in the Southwest ¼ of Section 28, Township 36, Range 5, West of the 3<sup>rd</sup>, as shown within the bold dashed line on a Plan Showing Proposed Lane Closure prepared by Brad J. Luey, Saskatchewan Land Surveyor, dated February 14<sup>th</sup>, 2024;

and attached as Schedule "A" to this Bylaw, is permanently closed.

### Authorization to Carry Out Bylaw

4. The Mayor and City Clerk are authorized to execute all such documents as may be necessary to carry out the intent of this Bylaw.

### Coming Into Force

5. This Bylaw comes into force on the day of its final passing.

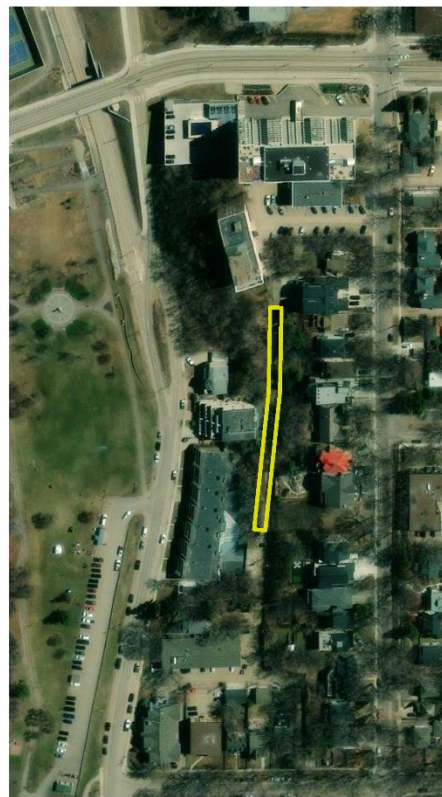

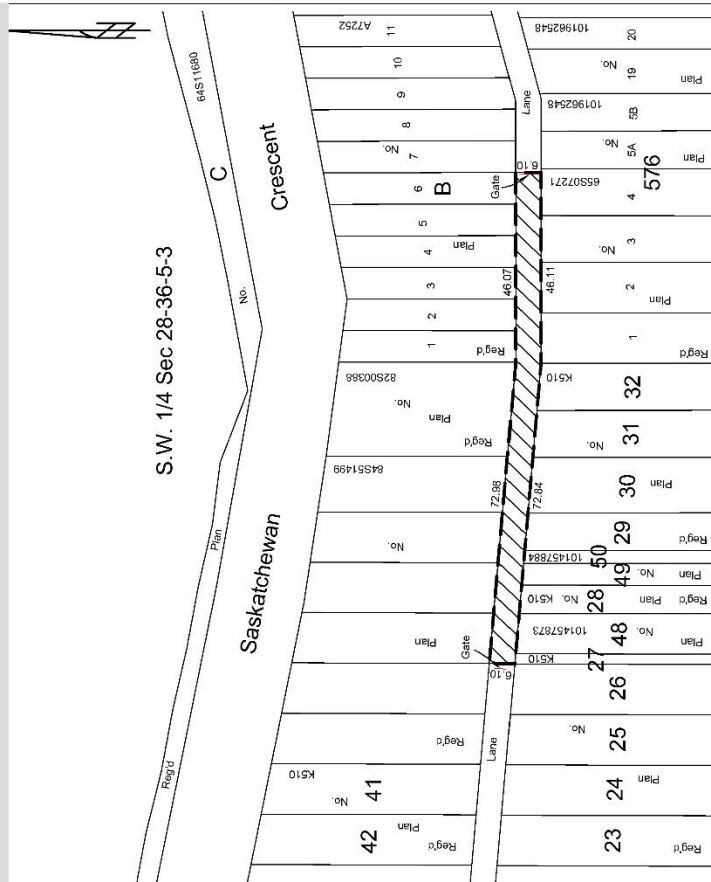
