**Comments:**

To the Standing Policy Committee on Transportation,

I am really excited to see progress being made in terms of safer pedestrian and cycling infrastructure in Saskatoon; it makes sharing the road safer for everyone. I bike and walk and take the bus everywhere I go; the status quo is pretty bad so it's really heartening to see some move towards improvements in this area. For this week's meeting I wanted to voice my support specifically for the following two items:

7.1.1: Connecting 2nd Avenue/3rd Avenue: Walking, Cycling, and Driving Improvements [TS2024-0504], I support Option 2A – Widen to the West.

No cyclist or pedestrian likes trying to guess if cars will stop for them, and most drivers also find it pretty stressful watching out for pedestrians or cyclists trying to cross the road at unmarked intersections because the marked ones are few and far between. Pedestrian controlled signals and a shared use path are a great way to make things more obvious and safer for everyone.

7.1.2: Opportunities for Rapid Deployment of Safety Improvements on Active Transportation Routes – May 2024 Update [CC2023-0602, TS2023-1003, TS2023-1204], I support Option 2: Implement a Neighbourhood Bikeway using Rapid Deployment on Route 6.

Traffic near the university is always difficult, and encouraging more and safer cycling is a good idea. Having an actual bikeway to get to campus would be great and is long overdue. (Many times I have been cycling in this town and had cars tell me to go ride on the bike path when the closest one is quite far from where I'm actually cycling; I'm not sure if they just think there are more bike paths than there actually are or something else but more bike paths would be great.)

I hope you will support these items and recommend them to your colleagues at city council!
