Dear Mayor Clark and Council Members:

We are writing to you today to urge you to seriously consider the details outlined in the Swale Watchers' position paper on the Saskatoon Freeway Phase 2 Functional Planning Study. Further, we urge you to carefully read the position paper and vote in favour of the Swale Watchers recommendations to not endorse the proposed design that would cause irrepairable damage to the precarious and vital lands of the Northeast and Small Swales.

We live in a beautiful city, one whose designers and planners have had the foresight to protect natural areas and who recognized the importance of building a place to live that is in harmony with nature. The efforts to preserve and protect the Meewasin Valley, for example, has ensured we live in an urban environment with nature just steps away for residents to enjoy.

The physical and psychological benefits of having easy access to nature are undeniable. Saskatoon is the envy of the world for our commendable and careful approach as stewards of natural habitat and our efforts to preserve and protect for future generations.

We urge City Council to consider the following:

Given that the Biological Assessment and the Functional Planning Study for Phase 2 of the Saskatoon Freeway demonstrate that irreversible harm would befall the Northeast and Small Swales–two of Saskatoon's most valuable and valued natural areas—if the project proceeds as proposed, we urge you NOT to endorse Phase 2.

Recognizing that the ultimate authority over where, when or if this project is completed lies with the province, rather than with the City of Saskatoon, we urge you to call on the Government of Saskatchewan to choose a route for the Saskatoon Freeway that does not intrude on the Swales. Please vote NO to the Phase 2 Proposed Saskatoon Freeway alignment through the Northeast and Small Swales.

We beg to differ with Joni Mitchell, who wrote, "You don't know what you've got 'til it's gone." In this care, we do and the legacy of this Council can rank with those around the world who have boldly chosen to preserve the natural habitat for future generations.
