During discussion, the Commission was further informed that rezoning applications or an increase in density on a property are reviewed by City Administration, including Saskatoon Water for site servicing. Infrastructure requirements, particular to a development through a rezoning process, are the responsibility of the developer.

The Administration also clarified the difference between the Corridor Growth Area and the Transit Development Area. The Corridor Growth Area is the area defined through the growth plan from 2016, an area that is more or less around 250 metres from the Bus Rapid Transit (BRT) route. The Transit Development Area is about 800 metres from a planned BRT station and is essentially an extension of the corridor area.
